I understand that weed torches are not allowed to be used.

I understand this permit is valid for the calendar year.

I understand I must receive approval prior to burning by logging on to our website at www.fryfiredistrict.com and then follow the directions under the “burn permit” tab.

Individuals without internet access may call 378-2222 or 378-2665 to receive approval.

Due to emergency calls and other fire district activities, calling the station will oftentimes not be successful, therefore, we encourage you to utilize the website.

Approval is based on weather and fire conditions. Please do not call before 9:00 am, this allows us to assess the conditions for the day.

I Understand burning hours are from 9:00 am to 4:00 pm daily.

The Fry Fire District performs random inspections to ensure the conditions of the permit are met.

Permit Details General

Burn must be extinguished when ordered by authorities.

Fire must be started without making black smoke (i.e. do not use gas or diesel fuel to start fire).

No burning during any air stagnation advisory.

No burning during any air pollution episode.

No burning when smoke may become a nuisance or safety hazard.

Applicant must have a copy of a valid permit on site when burning.

The burn permit does not relieve the permittee of liability from damages or obligation to comply with other laws.

The type of material to be burned consist of brush, grass, weeds, cut tree or untreated lumber.

Garbage is not allowed to be burned.

The quantity of material to be burned will be in a 4X4X2 pile or less or material will be situated in a pit or burn barrel.

Emission Reducing Techniques (ERT)

Minimize material to be burned

Prevent fire from spreading by lining the area where open burn is conducted with water.

Allow material to dry before burning

Minimize soil content in slash piles by constructing piles under dry soil condition or by using hand piling methods

Burn in piles

Extinguish the smoldering burns

Burn prior to precipitation

Proximity to Structure(s)

The distance from the burn location to the nearest structure must be 50' or greater?

Fire Extinguisher

There be at least one (1) fire extinguisher with minimum rating of 4A or other approved means of fire extinguishment (e.g. garden hose) on site during burning operations

Important Items & Legal Considerations

The fire shall be attended at all times. All fires must be extinguished before leaving them unattended.

The nearest fire department is the Fry Fire District.

A person who violates A.R.S. 12.1706 is guilty of an offense as follows: a. If done with criminal negligence, the offense is a class 2 misdemeanor... b. If done recklessly, the offense is a class 1 misdemeanor...

A person who violates A.R.S. 12.1706 is also guilty of an offense as follows: c. If done intentionally or knowingly and the person knows or reasonably should know that the person's conduct violates any order or rule that is issued by a governmental entity and that prohibits, bans, restricts or otherwise regulates fire during periods of extreme fire hazard, the offense is a class 6 felony.

A person who violates A.R.S. 12.1706 is guilty of an offense as follows: d. If done intentionally and the person's conduct places another person in danger of death or serious bodily injury or places any building or occupied structure of another person in danger of damage, the offense is a class 3 felony.

By affixing my signature to this document, I certify that I have knowledge of the facts herein set forth, that the same are true, accurate and complete to the best of my knowledge and belief. I further state that I will assume responsibility for conducting open burning in accordance with the Arizona Administrative Code, Title 18, Chapter 2, Article 3, Section R18-2-602 and any open burning permit issued thereof. I also understand that the Fry Fire District may revoke this permit at any time.
